

Contests and Awards Overview

Any Circle K Club or member in good standing (i.e. dues paid) is encouraged to apply by the designated deadlines below and on each contest. Dues payments for clubs and members are subject to verification with Circle K International and the Pennsylvania District's dues records. If a Circle K Club is more than two (2) months behind on submitting club officer monthly report forms (MRFs), the club may not apply for any contests unless the reports have been submitted to the International.

Circle K Clubs and members do not need to attend the annual District Convention to apply for awards.

The time period for reported activities for Circle K contests are for activities that occurred after the start of 2024 Convention (March 22, 2024) until the start of the 2025 Convention (March 28, 2025) unless otherwise stated on the awards form. Please ensure that if you use a project, activity, article, certificate, or letter that it falls between these designated dates. Items not used in this time frame can cause an entry to be disqualified.

All contest entry forms must be typed. In addition, please make sure that all appropriate documentation and signatures are obtained before submission. Treat the entries as you would a submission of a formal project or essay for class. Detailed and complete sentences (except when noted) with appropriate grammar should be included in all entries.

Entries are expected to be completed by Circle K members unless indicated otherwise. It is important that Circle K members are the primary contributors in all applications. While Circle K members may seek the advice or counsel from Faculty/Staff or Kiwanis Advisor(s)/Member(s), the Circle K members should be the primary contributors.

Entries should be brought to the District Convention and given to the District Administrator or judge before judging begins after Friday Night Opening Session.

Decisions of the judges are final and no changes, alterations, or recalculations will take place after the results have been certified.

Last, we ask that all Circle K members, Faculty/Staff Advisors, and Kiwanis Advisors/Members please be respectful of all the contests offered by the Pennsylvania Circle K. These are meant to recognize club and individual accomplishments and should be seen as a "friendly competition".
